

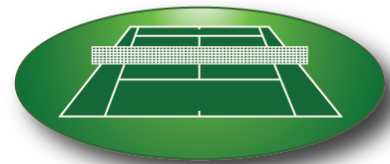

**PLEASE HAVE TENNIS COURT WATER SUPPLY TURNED ON AND ALL COURT SUPPLIES OUT BY TENNIS COURT BEFORE HTC BEGINS WORK OR AN ADDITIONAL SERVICE CALL FEE WILL BE CHARGED.**

This service will include the following:

1. Removal of weeds/debris/dead court material.
2. Renewal of court surface with up to 2 (two) tons of Hydroblend material.
3. New line tapes installed in accordance with USTA specifications.
4. Scraping and repainting of metal net posts in green or black.
5. Installation of owner's net and center strap.
6. Rolling the court 5 times.
7. Hydro system opened and filled (levels checked).

Please read and select, if applicable:

If line tapes and nails are provided by the owner, \$100 (\$108.63 with tax) may be deducted.

Windscreens will be installed for an extra labor charge of \$70 per man hour, \$90 per supervisor hour, plus materials. New tennis net may be installed for an additional charge of \$350.

Wood net posts may be refinished for an extra fee of \$500.

If court has severe weed growth additional labor charges may be incurred.

**Desired Reopening Date:**

**Reopening Dates are Assigned on a First Paid First Served Basis According to the Date of Receipt of Contract and Payment of Deposit and are NOT guaranteed due to the possibility of inclement weather.**

An additional fee of \$500 will be charged for all LAST MINUTE or EXPEDITED requests for court openings.

***We hereby propose to furnish material and labor, complete in accordance with the above specifications, for the sum of Two Thousand Eight Hundred Fifty Dollars plus NYS sales Tax (8.625%), which equals \$3,095.81***

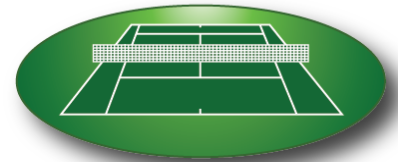

### 2016 SEASONAL MAINTENANCE OF YOUR HYDRO TENNIS COURT.

**PLEASE COMPLETE AND RETURN WE MUST HAVE A SIGNED CONTRACT TO UNDERTAKE WORK.**

We will visit your court as per your instruction to perform the following service:

Patch and weed court surface (does not include drainage trench), remove debris, brush, roll with motorized roller, re-brush, brush the lines, sweep the perimeter edge of the court and empty the tidy court trash receptacle.

Should this court service take longer than the total allocated time of one man hour due to poor court conditions (i.e. very rough play, sprinkler malfunction, etc.) the customer will be billed at the rate of \$70 per man hour, \$90 per supervisor hour.

**Please Note:**

- **Fast-Drying (Har-Tru) material used for patching is charged at the rate of \$25 per 80lb.**
- **The drainage trench will be cleaned at the client's request charged at the above rates.**
- **Hydro system check/adjustment is NOT included in this maintenance service. Please sign up for the Water Watch service, which will allow us to check/adjust the water level in the hydroboxes.**

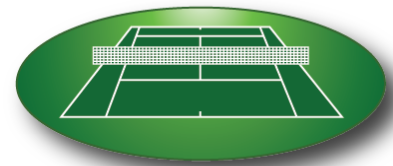

### 2016 SEASONAL WATER WATCH SERVICE FOR YOUR HYDRO TENNIS COURT

#### **WE MUST HAVE A SIGNED CONTRACT IN ORDER TO UNDERTAKE WORK.**

While we are at your court during your **regularly scheduled maintenance visit** we will perform the following additional service:

- During each visit we will inspect your tennis court, notify Hamptons Tennis Water Watch coordinator of the condition of your court (i.e. water levels, surface conditions, too wet, too dry, etc) and make any necessary Hydrocourt system water level changes.
- You hereby authorize Hamptons Tennis Company, Inc. to undertake any Hydrocourt system water level changes.

The customer will be billed at the rate of \$50 for each Water Watch undertaking, which must coincide with a scheduled visit. If you or your representative requests Hamptons Tennis Company to dispatch a Water Watch Technician to your court, in addition to your regularly scheduled visit, you will be billed at a rate of \$175 per visit, plus the costs of any materials used. Should this service take longer than the total allocated time of 30 minutes the customer will be billed at the rate of \$70 per laborer, \$90 per supervisor per hour.
